



**PERIODIC DISCLOSURE ON THE PURCHASE OF OWN SHARES

OVS S.p.A. ("OVS" – OVS.MI) informs to have purchased on *Euronext Milan*, in the period between 23 December 2024 and 27 December 2024, no. 115,524 ordinary shares (equal to 0.0397% of the share capital) at the average unit price of Euro 3.3813 for a total amount equal to Euro 390,621.30. Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of 24 January 2024, implementing the purchase program launched on 5 February 2024 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
