



**PERIODIC DISCLOSURE ON THE PURCHASE OF OWN SHARES

OVS S.p.A. ("OVS" – OVS.MI) informs to have purchased on *Euronext Milan*, in the period between 23 March 2026 and 27 March 2026, no. 320,172 ordinary shares (equal to 0.126% of the share capital) at the average unit price of Euro 4.2989 for a total amount equal to Euro 1,376,391.85.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of 30 May 2025, implementing the purchase program launched on 9 June 2025 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. no.58/98).
