

## FIRST QUARTER 2026 ORGANIC SCOPE: SALES +7%, EBITDA +27% DOUBLE-DIGIT GROWTH FOR GOLDENPOINT AND STEFANEL

The Board of Directors of OVS S.p.A. has approved the results for the first quarter of 2026 which, on an **organic scope**<sup>(1)</sup>, saw **net sales** increase to **€381 million, +7%** compared to the same period in 2025, with adjusted **EBITDA** jumping by **+27%** to **€35.7 million**. During the period, the **EBITDA margin** on sales increased from 7.9% to **9.4%**.

All major banners and brands recorded excellent performance, with positive results across every product segment. Women's collections continue to grow at a double-digit rate.

The integration of **Goldenpoint** is progressing **excellently**. Compared to the first quarter of 2025 – when the company was not included in the group's scope – **sales grew double digits**. The related EBITDA, although typically negative during this period due to seasonality, shows a significant improvement and points to a positive full-year result in line with the turnaround plan.

On a consolidated level, **net sales** reached **€397 million**, an increase of **+12%** compared to the same period in 2025, with an adjusted EBITDA of **€29.4 million**.

During the quarter, the operating cash profile recorded an **improvement of €7.5 million**. As of 30 April 2026, adjusted financial debt stood at €260.6 million, with a leverage ratio further improving compared to 30 April 2025.

**Second quarter sales also continue to maintain good growth.**



## **Statement by the Chief Executive Officer, Stefano Beraldo**

*"During the quarter, the market was positive, growing by approximately 2%, but all the major banners and brands of the OVS group achieved much higher growth, highlighting the ever-increasing solidity of our commercial positioning and the effectiveness of our product choices.*

*Within the organic scope, OVS and Upim grew by 7% and 9% respectively, while Stefanel achieved double-digit growth, reaching break-even during the period, which testifies to a strong acceleration in its turnaround process.*

*All key commercial indicators are positive. The increase in store footfall, combined with an improving conversion rate, drove growth in sales volumes, and the average ticket value is also on the rise.*

*Results spanned all product segments – childrenswear, menswear, and womenswear – with the latter confirming its position as the main growth driver. Beauty also maintains a very strong trend.*

*Thanks also to the increase in the commercial margin and cost control, organic EBITDA increased by 27% to €35.7 million.*

*The performance of Goldenpoint, integrated since July 2025, was excellent, closing the quarter with strong sales growth compared to the same period last year and an increasing gross margin, also thanks to purchasing synergies. This is a significant result given that it is the first period featuring predominantly collections developed by our style offices, with an effective balance among the different product categories and the launch of a store restyling plan, which is yielding excellent results."*

## **Outlook**

The positive top-line performance recorded to date, combined with the improved quality perception of the OVS banner and the appreciation of the house of brands strategy – characterized in particular by the excellent performance of PIOMBO and Les Copains, as well as all other brands – allows us to look at the remainder part of the year with optimism.

The table shows the main economic results adjusted to represent the group's operating performance net of non-recurring events which are unrelated to ordinary operations and the effects of the adoption of IFRS 16.

### Net sales

In the first quarter of 2026, net sales reached €397.2 million, marking an increase of 12.1% compared to the same period in 2025.

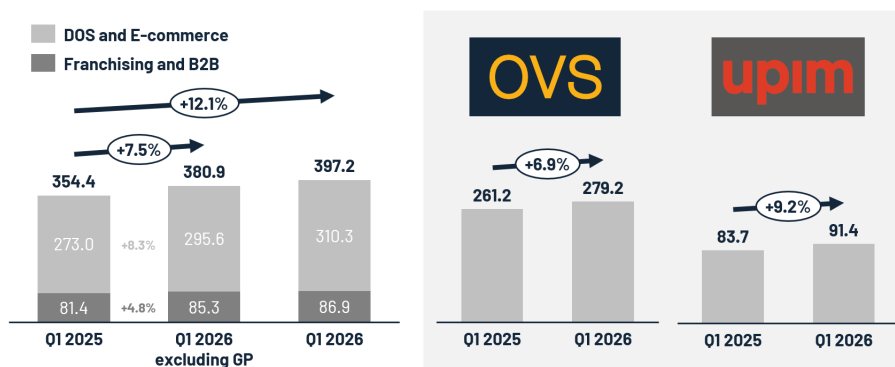
Excluding the contribution of Goldenpoint, growth stood at 7.5%, significantly outperforming the reference market, which recorded +2.3%.

In terms of distribution channels, the increase was 8.3% for directly operated stores and 4.8% for the franchising and B2B channel.

The OVS and Upim banners grew by 6.9% and 9.2% respectively. Stefanel particularly stood out, achieving 30% growth during the period, 19% of which was on a like-for-like basis.

Goldenpoint contributed €16.3 million, up 11% compared to the first quarter of 2025.

Net sales by Distribution channel and of Main Banners (€m)



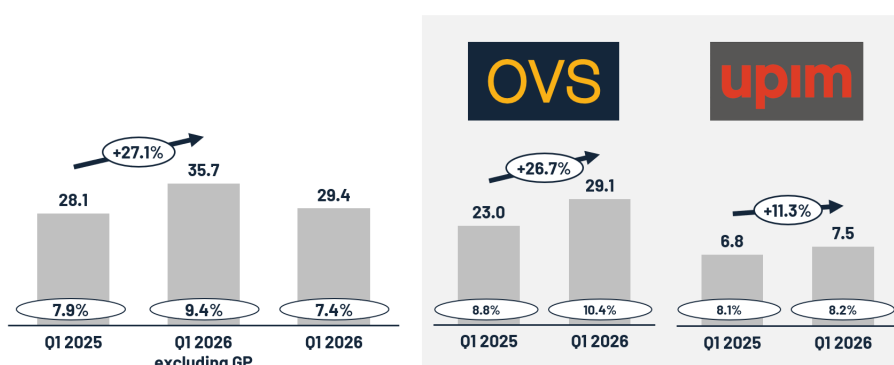
## EBITDA

In the first quarter, the group recorded an adjusted EBITDA of €29.4 million. The decrease in the EBITDA margin, which went from 7.9% to 7.4%, represents a technical decline linked to Goldenpoint's seasonality – an effect that will be fully absorbed over the course of the financial year.

On an organic basis, EBITDA shows a growth of 27.1%, from €28.1 million to €35.7 million, with the EBITDA margin increasing by 145 basis points, from 7.9% to 9.4%.

Looking at individual banners, OVS's EBITDA stood at €29.1 million (+26.7%), while Upim's rose to €7.5 million (+11.3%). It is worth highlighting the significant performance of Stefanel which, thanks to a sharp surge in sales, reached break-even.

## Net debt

As of 30 April 2026, leverage improved compared to 30 April 2025, with the consolidated operating cash profile recording a better performance by €7.5 million compared to the same period in 2025. During the quarter, €9.5 million were allocated to the purchase of treasury shares.

## **Performance Shares Plan 2026-2028: beneficiaries and maximum number of rights**

With reference to the incentive plan named "Performance Share Plan 2026-2028" (the "Plan"), approved by the Shareholders' Meeting on 29 May 2026, it is hereby announced that today, the Board of Directors, following the favorable opinion of the Nomination and Remuneration Committee, has identified 30 beneficiaries, including the Chief Executive Officer Stefano Beraldo. The beneficiaries include executives with strategic responsibilities, employees and consultants of the Company.

The Board of Directors has also resolved to grant the beneficiaries rights to receive shares of the Company up to the maximum number indicated for the Chief Executive Officer as 2,218,500, for a Director - by virtue of their employment relationship with the Company - as 100,755, for the 4 Executives with Strategic Responsibilities as a total of 1,242,360 and for the other 24 beneficiaries as a total of 1,368,385 rights.
