OVS S.p.A. (OVS.MI) announces that, during the period between 29 June 2026 and 03 July 2026, it purchased no. 55,710 ordinary shares on Euronext Milan (equal to 0.022% of the share capital) at an average price of 5.9379 Euro, for a total consideration of 330,799.69 Euro.

The transactions were carried out in implementation of the share buyback program launched on 1 June 2026, pursuant to the authorization approved by the Shareholders' Meeting on 29 May 2026.
