OVS S.p.A. (OVS.MI) announces that, during the period between 21 September 2026 and 25 September 2026, it purchased no. 299,309 ordinary shares on Euronext Milan (equal to 0.117% of the share capital) at an average price of 5.6567 Euro, for a total consideration of 1,693,096.77 Euro.

The transactions were carried out in implementation of the share buyback program launched on 1 June 2026, pursuant to the authorization approved by the Shareholders' Meeting on 29 May 2026.
