



**DISCLOSURE ON OWN SHARES' PURCHASE IN THE PERIOD

Venezia-Mestre, October,18, 2018 - OVS S.p.A. (LEI code: 8156001A772766DCAA71) informs to have purchased on the *Mercato Telematico Azionario*, in the period October 12, 2018 and October 18, 2018, no. 127,000 ordinary shares (equal to 0.056 % of the share capital) at the average unit price of EUR 1.8744 for a total amount equal to EUR 238,046.13.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of last May 31st, 2018 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
