OVS S.p.A. (LEI code: 8156001A772766DCAA71) informs to have purchased on Euronext Milan, in the period 20 April 2023 and 26 April 2023, no. 132.631 ordinary shares (equal to 0.046% of the share capital) at the average unit price of EUR 2.6850 for a total amount equal to EUR 356,112.21.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of May 31st, 2022, in continuity with the own shares' purchase program started on February 2nd, 2022 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
